

Agreement for Vehicle or Boat

THIS AGREEMENT IS BOUND BY THE LAWS OF THE COUNTRY/REGION OF

Definitions:

"Owner" - The person who has legal ownership of the vehicle or boat

"User" - The person who has been given the right to operate the vehicle or boat

Owners' Agreement

I/We as owner, allow to use our

In the event that an insurer refuses a claim due to the User or nominated driver/skipper being drunk, not having the necessary licences or qualifications, or any other matter which allows the insurer to legally void their coverage, agrees to cover all associated costs to which the Owner otherwise would be liable.
